

PROGRAM UPDATE

trustea has verified 640 million KGs of tea till October 2019, which is almost half (48%) of the total tea produced in the country annually. *trustea* has been creating a positive impact by engaging with nearly 51,242 smallholder tea growers, 3.1 lakh female workers and 2.5 lakh male tea workers, and certifying over 631 estates and bought leaf factories for demonstrating progress and improvements under the good agricultural and manufacturing practices of the *trustea* Code.
