
From the **Director** 

At trustea, we have always believed that knowledge is power. Training forms the most important part of our activities. trustea is therefore very excited to have been offered the opportunity by HUL to partner in a large-scale small tea grower training programme on legally compliant usage of chemicals coupled with an introduction to the benefits of regenerative agriculture. The partnership has enabled us to embark on an ambitious programme of training across multiple locations in Assam and West Bengal in collaboration with industry associations and Bought Leaf Factories. We have also launched an app called TeaPlus which will aid farmers and estates with knowledge and live information on weather, soil as well as pest attack history for the specific location of the user. The app has an interesting feature where users can exchange updates and information on how they are managing their farming activities and combating pest infestation. This forum is expected to become a source of knowledge exchange which will be beneficial to the estates and the small farmers towards good agricultural practices for farming inputs that are compliant to the regulatory requirements.

As you may be aware, *trustea* is in the process of transitioning entities to Version 3 of the code. This work is on in full swing across the country. Currently more than 70 entities are actively working on the *trustea* code Version 3 implementation and certification to Version 3 has also started.

One of my greatest achievements in life is the day I achieved the ability to provide and support my family.


8. Mention one thing that few people know about you? A lesser-known fact about me is my talent for singing, which I hold with pride.



We conducted a day-long virtual interactive transition training on Ver. 3 for gardens in the McLeod Russell Group.

Earlier this month, we were part of a workshop organised by the Assam Bought Leaf Manufacturer's Association in collaboration with the Tea Board of India. They were held on 9th and 10th April at Udaipur near Lekhapani and Pengeri near Tinsukia with 175+ small tea growers from the local community in attendance. The focus was on the Integrated Pest Management (IPM) practices with minimal use of Plant Protection Formulas (PPFs). Among the topics discussed were PPFs that are safer to use in the tea plantations as prescribed in the Plant Protection Code (PPC) and by the FSSAI, along with latest updates on banned chemicals in tea. We provided insights on climate change impact on tea plantations, adoption of regenerative and Good Agricultural Practices (GAP) towards sustainable tea farming.





For the last four years, our tradition for International Tea Day includes the launch of our Year Book. This year too, we are happy to announce the launch of **Year Book 2023**. A momentous year, for we completed 10 years since our inception. We have also responded to new challenges and needs of the Indian tea industry and adapted our code to address them. Speaking at the event, Mr Bhuyan said, "If those at the bottom of the pyramid feel threatened, they will move out of the system. Where does the value of socially responsible companies come from? We listen to other voices, we listen to voices on the ground, and adjust our strategies."



*trustea* has embarked on a large-scale training program for small tea growers on the use of approved chemicals in tea cultivation. The program will cover the use of approved chemicals, awareness of banned chemicals, and adoption of integrated pest management solutions. The participants will also be introduced to regenerative agricultural practices which is considered the path ahead towards optimum agrochemical use.

The training program is being supported by Hindustan Unilever Ltd and has been launched in Assam at Ranjuli Tea Co. (19th June), Lakheshwari Tea Factory (20 June) and Hun jyoti Tea Factory (21 June), BL Tea at Golaghat (24 June) and Rajakhat Tea Industries (24 June).

In North Bengal, the training was held at the Uttorayon Tea Factory (24 June) where it was being organized in collaboration with the North Bengal Tea Producers Welfare Association (NBTPWA). We expect to continue this training series across North Bengal & North East India in the coming months towards raising the standards of tea production.





Rousdon Mullai Estate in Gudaluris a trailblazer in terms of providing proper sanitation facilities for female workers. They have constructed pink toilets in the plucking areas, equipped with vending machines for sanitary napkins. Having lavatory facilities in plucking areas is a mandatory criterion in Code Ver. 3, aligning with the compliance requirements of the Plantation Labour Act (PLA). This measure is essential to protect the honour and dignity of workers, particularly the female workforce, who start their day early and continue working in the plantation throughout the day.

We appreciate the effort taken by the garden management to provide such arrangements for their workers. This initiative creates a better environment by reducing the negative effects of open defecation in plantations and preventing soil and water contamination.
